Home Care Frequently Asked Questions

Q: What is Home Health Care?

A: Home Health Care is a service that permits patients to receive personalized health care, maintaining their quality of life in the privacy and comfort of their homes.

Q: Why Home Health Care?

A: Home Health Care is a cost-effective option for receiving health care services. Returning to one's home and family can promote quicker recovery and improve the quality of life for both patient and family or caregiver.

Q: What criteria must be met for Medicare to approve services?

A: *The following criteria are used to meet Medicare requirements:*

The patient must be a Medicare recipient.

The patient must be homebound. This is defined by Medicare as "normal inability to leave the home and leaving the home requires considerable and taxing effort."

The skilled care must be medically necessary as determined by a physician.

Q: Do I need a physician's order for Home Health Care?

A: Yes, skilled health care provided in the home occurs under direct order and supervision of the patient's physician.
